It is to inform that, the Government of Telangana constituted Telangana State Anti-Narcotics Bureau (TSNAB) to combat drug trafficking comprehensively including cultivation, production, transportation, smuggling, sale, purchase, possession or consumption of narcotics and Psychotropic Substances in the State of Telangana and TSNAB serves as 'Secretariat' for the State Anti-Narcotics Task Force.

Vide reference 1st cited, the G.O. Ms No 27 has envisaged the <u>"creation of Anti-drug committees in educational institutions, issue time to time guidelines for the functioning of its activities and monitor them".</u> Further, in compliance to the minutes of the meeting of 2nd State Level NCORD Committee meeting vide reference 2nd cited, the Secretary Higher Education, Commissioner of Technical Education and Secretary, TS Board of Intermediate Education, Hyderabad vide references 3rd to 5th cited have issued instructions

to all the Principals of Professional colleges/ Government / Private/ Polytechnic Colleges in the state to form Anti-Drug Committees (ADCs) similar to Anti Ragging Committees in their respective institutions adhering to the following auidelines issued by TSNAB.

- Constitute a Committee of at least 5 members to be known as the Anti-Drug Committee headed by the Head of the Institution, and consisting representatives of civil and police administration, NGO involved in youth activities, faculty members, parents, students, non-teaching staff etc.
- 2. The Institutions shall erect suitable warning hoardings/bill boards/banners in prominent places within the campus, to exhort the students not to indulge in drugs consumption.
- 3. Before the commencement of the academic session in any Institution, the Head of the Institution shall convene and address a meeting of various functionaries/agencies, such as Hostel Wardens, representatives of students, parents/guardians, faculty, district administration including the Police, to discuss the measures to be taken to prevent drugs in the Institution and steps to be taken to identify those indulging in or abetting drugs peddling/consumption.
- 4. The Institution shall give wide publicity among the students, through various means, about the Laws relating to drugs and the catastrophic consequences of drug consumption.
- 5. The Committee should conduct events like Anti-Drugs work shop, seminars, orientation programs, counselling, awareness programs, educating ill effects of drugs, sessions encouraging peer policing among students against drugs and reporting of any noticed use of drugs by students to authorities.
- The Committee shall intimate the local Police, if anyone is found or reasonably believed to be indulging in consumption or possession or sale or purchase of Narcotic and psychotropic drugs.
- 7. If any person comes to know any information regarding Narcotic Drugs and Psychotropic Substances, it shall be informed to the

- 8. It is hereby notified, that it shall be the overall responsibility of the Colleges and other equivalent educational Institutions and its management, to put in place other systems and checks, to eradicate the menace of Narcotic Drugs from in and around their premises.

Therefore, all the CsP/SsP in State should ensure the creation of ADCs in all educational institutions and to take up extensive awareness programs in their respective jurisdictions as envisaged in G.O. 27 and to carry out the following:

- To conduct meetings with the **Principals** / **Correspondents** to enlighten the importance of awareness on substance use and illicit trafficking.
- (02) Nodal officers to be appointed not below the rank of DSP/ Inspector and (01) Sub-Inspector as Resource Person from Commissionerates and Districts respectively.
- 3. These Resource Persons from the respective units will be trained by the TSNAB and liaise with the officers of TSNAB on the subjects of

Awareness, Functioning of ADCs, Documentation, Investigation, Legal matters, Drug Disposal and other issues related to NDPS cases.
