INTERNATIONAL DRUG PEDLLERS HELD – SEIZED **(100) GRAMS COCAINE AND (300) GRAMS MDMA DRUG** **ALL W/RS.1 CRORE**

The TS-NAB along with H-NEW and Banjara Hills Police on credible information apprehended (3) International drug peddlers and (1) local peddler who were in possession of Narcotic drugs i.e. Cocaine and MDMA. Seized **(100) Grams Cocaine, (300) Grams MDMA and (5) Cell phones all W/Rs.1 Crore** from their possession.

Details of Accused persons:

- 1) Agbowo Maxwell Nnabuisi @ Kweku Essuman Kwame, S/o Nanna, Age: 37 Years, Occ: Drugs supplier, R/o Bangalore, N/o Nigeria.
- 2) Okeke Chigozie Blessing, S/o Okeke, Age: 32 Years, Occ: Drug Peddler, R/o Tripur, Tamil Nadu, N/o Nigeria.
- 3) Ikem Austin Obaka @ Kingsley @ John, S/o Ikem, Age: 41 Years, Occ: Drug Peddler, R/o Bangalore, N/o Nigeria.
- 4) P.Sai Akesh S/o Late P.Venkat Rao, age 25 yrs, Occ: Drug peddler, R/o Flat No.502, Naimisan Apartment, Sri Nagar colony, Hyderabad.
- 5) M. Sanjay Sunil Kumar, S/o Sunil Kumar, Age 27 Years, R/o Thrissur, Kerala – **Arrested**.
- 6) Tumma Bhanu Teja Reddy, S/o T. Nagi Reddy, age 23 yrs, R/o Alkapuri, Manikonda, Hyderabad – **Arrested**.
- 7) Mazee, R/o Bangalore, N/o Nigeria – **Absconding**.

Seized material:

- 1) Cocaine – 100 Grams.
- 2) MDMA – 300 Grams.
- 3) Cell phones – 05.

Brief about the accused persons:

In the year 2011 the accused Agbowo Maxwell Nnabuisi @ Kweku Essuman Kwame came to Mumbai, India on Medical VISA. After few months he moved to Bangalore.

In the year 2012 the accused Okeke Chigozie Blessing came to Mumbai, India on business VISA and moved to Tripur of Tamil Nadu state. In the year 2022 he came to Bangalore and staying with the accused Agbowo Maxwell Nnabuisi.

In the year 2021 the accused Ikem Austin Obaka @ Kingsley @ John came to India on student Visa and took shelter at Bangalore.

Modus operandi:

After reaching to Mumbai the accused Agbowo Maxwell Nnabuisi started drug peddling business. Later due to the fear from the Police he moved to Bangalore and staying there. After reaching Bangalore he created a fake profile on the name of **Kweku Essuman Kwame** and also created fake Nigerian passport with a fake VISA on his fake name. By using the fake passport and VISA he took a rented house and Internet Connection at MS Nagar, Bangalore and started drug peddling business along with his friend Mazee. After few months he moved to Achyutha Nagar, Bangalore which is near to the colleges and Universities where he can attracts young college and university students to run his business easily. The accused used to use Virtual Phone Numbers to avoid apprehension by the Police, to segregate his personal and working hours without causing any disruption to his business.

The accused Agbowo Maxwell Nnabuisi along with Mazee who is his friend opened a bank account on the name of Evelyn Yerenkiwaa a Nigerian national in Nationalized Bank.

Later the accused persons Agbowo Maxwell Nnabuisi and Mazee came into contact with the remaining accused persons and offered to assist them in drug peddling business on commission basis. For which they agreed and all of them started drug peddling business at Bangalore and other surrounding areas.

The accused Agbowo Maxwell Nnabuisi @ Kweku Essuman Kwame used to provide the account details to the customers. After receiving the payments through online he drops the drug at an isolated place. He further sends the location of drug where he kept and also a photograph to the customers to collect the same. Sometimes he used to send the above accused persons to hand over the drug to needy customers. A part from the Bangalore, the accused persons are also selling the drug to the needy customers at Mumbai, Hyderabad and other areas.

The investigation is being continued to identify the Drug consumers who are purchasing the drug from the above accused persons.

Previously the accused persons i.e., M. Sanjay Sunil Kumar and Tumma Bhanu Teja Reddy were arrested in **Cr.No.505/2023 U/s 8(C), 22(B), 27, 29 of NDPS ACT-1985 of Banjara Hills PS.**

In pursuance of the confession Statement of M. Sanjay Sunil Kumar and Tumma Bhanu Teja Reddy made sustained efforts and the TS NAB, H-NEW unearthed (100) grams Cocaine, (300) Grams MDMA from their secret possession and also seized 5 Mobile Phones. Further, the seized material was handed over to **SHO, Banjara Hills Police Station**, Hyderabad for further investigation in the case.

- The deportation is being under process to deport the Ghana Nation by name **Felix Awunyo S/o John Awunyo, Age: 36 yrs, N/o Ashy Street, Teshie, Greater Accra, Ghana** who accompanied with the accused Ikem Austin Obaka @ Kingsley @ John.

APPEAL TO THE GENERAL PUBLIC:-

In recent times we have seen several youth/students getting addicted to Drugs, committing crime and involving in other anti-social activities. Several families have become victims of this menace.
